The Cambridge International School, Patti, Block Patti, District Tarn Taran under section 18 of Right of Children to free and compulsory education Act 2009 and Punjab Children's free and the right to compulsory education rules, 2011. On the basis of the report received from the subordinate officers, letter issued by Honorable DGSE Punjab No. DGSE RTE/2016/1276-78 dated 25.01.2016 according to the instruction, the class from pre-primary to middle is recognized under the following conditions.

1. The institution/school will not charge any capitation fee nor will the child or his parents or guardian adopt any method of retrenchment.
2. School shall not refuse admission to a child for lack of proof of birth or if child approaches for admission after an extended period of time or for religion/casteism/birth place or any other reason and the act shall follow the provisions of section 15.
3. No child admitted by the Board shall be kept back in the class or expelled from the school until his elementary education is completed.
4. The school will not give physical punishment or mental distress to any child.
5. Every child who has received primary education from the school, will be given certificate as per rule 21.
6. The school will from time to time get the building safety, fire safety and water sanitation certificates and other required documents after expiry of the period and submit the copy at the office of the District Education Officer (AC), Tarn Taran. In case of failure to do so, action will be taken against the school as per RTE Act and rules regarding cancellation of recognition.
7. The school building or other structure or grounds shall be used only for teaching or skill development and no unrecognized class shall be conducted inside or outside the building.
8. It is necessary for the teachers that they fulfill the educational qualification as per section 23(1).
9. The School will follow the instructions issued by the Education Department from time to time. The rest of the conditions will be as per the provisional certificate issued earlier. The recognized code number of the school will be RTE TARN TARAN -19080413
10. The school institution will be bound to implement all the terms and conditions of the RTE Act, 2009. If the school/ institution is found violating regarding any section /rule of the RTE Act 2009 of the instructions issued by the department, the recognition of the school will be cancelled.
