RULES AND REGULATIONS OF THE SOCIETY

INTRODUCTION

These rules and regulations of Society named **British Education Society, Khem Karan Road, Patti, Distt. Tarn Taran**, has been framed with a view to run the smooth functioning of the society and shall be strictly adhered to by all the members throughout their period of membership. The rules and regulations shall not be changed, altered or amended without the consent of the General Body of the Society.

Area Operation : Distt. Tarn Taran.

ELIGIBILITY FOR MEMBERSHIP

Any adult person whether male or female, who respect the basic of social welfare of the citizens and inclined to dedicate themselves to the cause of enlistment of the society and agree to abide by the aim of objects and rules and regulations here in after framed of the society. As the application for membership shall have to be approved by Governing body which reserves the right to admit or reject without assigning any reason whatsoever. Membership shall be granting after passing a resolution of this effect by 3/4th majority of governing body. The membership of any member cannot be withdrawn, changed, cancelled, dismissed without the resolution passed by 3/4th members of Governing Body.

MEMBERSHIP FEE

Along with the prescribed application for Membership of society a non-refundable an admission/membership fee of Rs.200/- or as decided by the General Body is payable.

SUBSCRIPTION

Every member shall pay a monthly subscription of Rs.200/- and shall deposit the same with the Treasurer who will issue a proper receipt of the same. (Membership fee and subscription subject to amendment)

DIS-QUALIFICATION

No person shall be entitled to become a member of the society if He/She

- (i) Dies or becomes of unsound mind.
- (ii) Fails to attend three continuous meetings of the society.
- (iii) Will not pay subscription for three months continuously.
- (iv) Has been convicted by a court of law for an offence of moral turpitude.
- (v) Has resigned.
- (vi) Is found guilty of misconduct or misbehavior during the meetings or found misusing the name of the society for his/her wrongful personal gains.

REGISTER OF MEMBERS

The Society shall maintain at the registered office a register of its members along with their complete bio-data and shall enter, therein within fifteen days after the admission of a member or the cessation of his membership as case may be.

RESIGNATION & EXPULSION

A member may resign with a prior notice of 7 days and subject to the approval/rejection of the same by the President of the Society. Similarly a member can be expelled by the President with the consent of the majority member of the Society. On submission of his resignation, after having cleared-off all his dues and/or liabilities and acceptance thereof.

FORMULATION OF THE GENERAL BODY

The general body of the society shall consist of all General members and the members of the governing body. Apart from this, the general body shall include any invitee or guest appointed by the Governing body.

POWERS OF THE GENERAL BODY

The general body of the society shall assist the governing body in the implementation of the aims and objects of the society. The members of the General Body guide the governing body from time to time in the matters of initiating any activity on preferential basis. The General Body shall have overriding effect on the governing body and can check the governing body if it feels any dissatisfaction over the working of the governing body.

MEETING AND QUORUM OF THE GENERAL BODY

The general body of the society shall conduct at least one meeting in three months. The quorum of meeting shall be 3/4th members of the general body.

QUORUM

The quorum of the meeting shall be 2/3rd of the total number of members of the society.

POWERS OF GOVERNING BODY

PRESIDENT

1. He shall preside over all meetings.
2. He will sign all the documents of the Society.
3. He will supervise and guide all activities of the Society and conduct the proceedings of the meetings.
4. He shall exercise directional and administrative authority over all the officer bearers.
5. He shall exercise the right to the casting vote in the case of tie.
6. He shall have to right to give finally decision all questions arising at any meeting and his decision shall be final and binding upon rest of the members.

VICE PRESIDENT

He/She performs all the duties of president in the absence of the Vice President.

SECRETARY

He/She shall be the incharge of the office of the society and shall act as adjutant of the society. He is the first man to know everything about the activities and functions of the society and amongst other things to do the following acts, deeds and things, namely

- (i) To check and verify accounts in the cash book and carry out periodical inspection of the same.
- (ii) To sign and issue notices for calling meetings of the governing body general body and to issue press release on behalf of the society.
- (iii) To look after the conduct all correspondence relating to or in any way concerning the society, record and put up before the authority concerned.
- (iv) To call and conduct the meetings of the Governing body and the General body of the Society.
- (v) To keep or cause to be kept in proper order and custody all documents and all papers and files belonging to the society.

CASHIER

He shall be the overall incharge of the finance of the society and its cells and shall receive memberships fees, subscription, donations in cash and record the receipts in cash-book maintained for the purpose.

EXTRA ORDINARY MEETING

The President will call extra ordinary meeting of the Governing Body when: -

- (a) The Governing Body has some urgent and important business falling within the purview of the Governing Body is to be transacted.
- (b) On a requisition received in writing by not less than 3/4th of the total number of members of the Governing Body.

NOTICE FOR MEETING

- (a) The Secretary will give the notice of every meeting to all the members of Governing Body and this notice will mention agenda of the meeting. 7 days clear notice for annual general meeting and three days notice for its extra ordinary meeting will be given.
- (b) The meeting of the Governing Body will be called by giving a clear two days notice while emergent meeting may be called by 24 hours notice in advance.
- (c) Any accidental omission however, to give notice or non-receipt of notice by any member entitled thereto shall not invalidate or vitiate the proceedings of the meeting held in pursuance of such notice.

PROPERTY OF THE SOCIETY

The property moveable or immovable of the Society shall vest in the name of the Society and no individual member shall have any proprietary right over it.

ELECTION

The elections of Governing Body of the Society will be held after **one** year. The members shall cast their vote by raising of hands or by ballot. After a period, two years, the new members of the governing body shall be entitled to contest elections for, as many times they want.

BORROWING

The Governing body of the society is authorized to raise loan from bank in further cause of its objects to implement the ongoing project of the society. The property of society can be mortgage/charged for the purpose of raising loan and to secure that loan.

FUNDS OF THE SOCIETY

The funds of the Society shall consist of: -

- (a) Regular subscription from members.
- (b) Special project money &/or contributions by the members, if and when, required by the Society to meet up the special project or problem.
- (c) Donation/grants from Govt./Semi-Govt. or the Well-wisher of the Society.
- (d) Other legitimate means if any.

BANK ACCOUNT

The Bank of the Society will be any bank decided by the Governing body.

ACCOUNTS:-

Accounts will be maintained from April to March. The accounts will be maintained by the President, Secretary & Cashier with any other member of the Society.

ADDITION & ALTERATION IN RULES & REGULATION

Any addition, alteration or omissions in the rules and regulations will be effected by a resolution of the Society by 3/4th of members present in person and entitled to vote a General meeting of the so duly convened. So far as concerns the alterations, extensions or abridgements in the purposes of the so, the provisions of section 12 of the societies reg. act 1860 shall apply.

GENERAL MATTERS

- (a) No member shall have more than one vote at any of the meetings, except that in case of the equality of votes President shall have casting vote.
- (b) In case of a vacancy of the Governing Body due to any reason the President out of the members of the General body shall fill it in for the remaining period.
- (c) Any change in the Office-bearers or in the membership of the Society will be intimated to Registrar of Societies in accordance with the provisions of the Societies & Registration Act 1860.
- (d) In the matter of any dispute if and when arise the legal proceedings by or against the Society shall be instituted by Secretary in the name of Society for the time being. The jurisdiction shall be only at India.

DISSOLUTION

The Society can be dissolved only by the 3/4th majority of the Society. For the dissolution of the Society, fifteen days notice should be issued to all the members of the Society. In the case of dissolution of the Society all the assets of the Society be handed over to the Society existed that time whose aims and objects will be similar to the Society.
